Catalog Description:

HVS6522 - VARSITY BASEBALL II (P) (1 hr)

Student participation in baseball on an intercollegiate level.

Prerequisites:

None

Controlling Purpose:

The purpose is to provide the student with an opportunity to participate on an intercollegiate level in baseball. Teamwork, participation, and responsibility are to be stressed along with developing good physical fitness.

Learner Outcomes:

Upon completion of the course, the student will be able to develop a high degree of skill in baseball, and will also become familiar philosophy, strategy, and mechanics of baseball at the intercollegiate level

Units Outcomes and Criterion Based on Key for Core Content:

The following outline defines the minimum core content not including the final examination period. Instructors may add other material as time allows.

Evaluation Key:

- A = All major and minor goals have been achieved and the achievement level is considerably above the minimum required for doing more advanced work in the same field.
- B = All major goals have been achieved, but the student has failed to achieve some of the less important goals. However, the student has progressed to the point where the goals of work at the next level can be easily achieved.
- C = All major goals have been achieved, but many of the minor goals have not been achieved. In this grade range, the minimum level of proficiency represents a person who has achieved the major goals to the minimum amount of preparation necessary for taking more advanced work in the same field, but without any major handicap of
